Arcmont Awards

- 2025 Debtwire's European Mid-Market Direct Lender of the Year and Mid-Market Direct Lending Deal of the Year were awarded in June 2025. Arcmont submitted self-nominations for each award and was selected as the winner from a shortlist of 4-5 finalists for each respective category by a panel of judges consisting of third-party industry professionals. No payment was made for the award submission although a payment was made to purchase a table to attend the awards ceremony.
- Arcmont won Lender of the Year – Alternative at Real Deals' Private Equity Awards in April 2025. No payment was made in connection with this award. Shortlists were determined by the Real Deals editorial team and then judged by a panel of LPs and PE professionals
- 2024 Debtwire's European Large-Cap Direct Lending Fund of the Year & DACH and Poland Lender of the Year was awarded in June 2024. Arcmont submitted self-nominations for each award and was selected as the winner from a shortlist of 4-5 finalists for each respective category by a panel of judges consisting of third-party industry professionals. No payment was made for the awards submission but a payment was made for Arcmont staff to attend the awards ceremony.
- 2025 Leverage Finance Award: Best Team – Unitranche Debt Large Cap at the 24th Private Equity Exchange (PEX) organised by Décideurs Corporate Finance and awarded in November 2025. This award was selected by a jury of debt advisory experts who chose the best players in Leverage Finance. No payment was made for the awards submission, and no payment was made for Arcmont staff to attend the awards ceremony.
- Arcmont won 2025 Direct Lending Deal of the year (mid-cap) at the Alternative Credit Awards 2025 awarded in November 2025. Arcmont submitted a self-nomination for the award and an independent panels of industry experts reviewed the submissions. Judges are drawn from across the credit and investment ecosystem to provide balanced perspectives. No payment was made for the awards submission but a payment was made for Arcmont staff to attend the awards ceremony.
- Debtwire Benelux Direct Lending Rankings February 2026 – Debtwire used a combination of submissions from direct lenders, their proprietary data and public information to rank lenders based on deal count and Arcmont provided information to Debtwire in December about the deals it completed during 2025. Arcmont paid no fee to Debtwire to be included in these rankings.
- 2026 Debtwire's France Direct Lending Manager of the Year and Benelux Direct Lending Manager of the Year were awarded in June 2026. Arcmont submitted self-nominations for each award and was selected as the winner from a shortlist of 4-5 finalists for each respective category by a panel of judges consisting of third-party industry professionals. No payment was made for the award submission although a payment was made to purchase a table to attend the awards ceremony.

Nuveen Private Capital Awards

- Nuveen Private Capital was selected as a "Lender Firm of the Year" in the 15th Annual International M&A Awards in July 2024 by an independent panel of judges appointed by the M&A Advisor. Winners announced in July 2024. Nominal fees were required to submit nominations.
- Nuveen Private Capital was named 2025 Institutional Direct Lender Firm of the Year in the M&A Advisor's 16th Annual International M&A Awards in September 2025. An independent committee of M&A, restructuring and deal financing industry business leaders judged all nominations. A nominal fee was required to submit a nomination.
- Nuveen Private Capital was named 2026 Corporate/Strategic Deal of the Year (Over \$1B) in the M&A Advisor's 17th Annual International M&A Awards in June 2026. All submissions are evaluated by an independent committee of industry leaders in M&A, restructuring, and refinancing. Judging is conducted on a secure datasite using trusted technology to ensure that every nomination is processed and reviewed securely and confidentially. A nominal fee was required to submit a nomination.
